**ORDINANCE OF THE CITY AND BOROUGH OF JUNEAU, ALASKA**

**Serial No. 2014-41**

**An Ordinance Proposing an Amendment to Section 3.20 of the  
Charter of the City and Borough Relating to the Ski Area Board.**

WHEREAS, the Assembly has determined that it is to the benefit of the public to place the management and operating responsibility of the municipally-owned ice rink under the direction of the Ski Area Board.

NOW, THEREFORE, BE IT ENACTED BY THE ASSEMBLY OF THE CITY AND BOROUGH OF JUNEAU, ALASKA:

**Section 1. Classification.** Section 2 of this ordinance, if approved by the voters pursuant to Section 3, is of a general and permanent nature and shall become a part of the Home Rule Charter of the City and Borough of Juneau, Alaska. Sections 3, 4, and 5 of this ordinance are noncode sections.

**Section 2. Charter Amendment.** Section 3.20, Ski area board, of the Home Rule Charter of the City and Borough of Juneau, Alaska is amended to read as follows:

**Section 3.20. Ski area board.** The assembly shall appoint members of a board of directors for the municipally-operated ski area and ice rink.

2 Notwithstanding the provisions of Section 3.16 of this Charter, the board shall  
3 derive its authority and power from the assembly by ordinance.

5 **Section 3. Submission of Question to the Voters.** An amendment to Section 3.20,  
6 Ski area board, of the Home Rule Charter of the City and Borough of Juneau, Alaska shall  
7 be submitted to the voters of the City and Borough at the next regular municipal election.  
8 The Municipal Clerk shall prepare the ballot and perform all necessary steps in accordance  
9 with law to place this proposition before the qualified voters at the next regular municipal  
10 election.

13 **Section 4. Proposition.** The proposition to be submitted to the qualified voters of the  
14 City and Borough, as required by Section 3, shall read substantially as follows:

19 Shall the Home Rule Charter of the City and Borough of Juneau, Alaska be  
20 amended by adding the underlined text to Section 3.20, Ski area board, to  
21 read as follows:

24 **Section 3.20. Ski area board.** The assembly shall appoint members of a  
25 board of directors for the municipally-operated ski area and ice rink.

2 Notwithstanding the provisions of Section 3.16 of this Charter, the board shall  
3 derive its authority and power from the assembly by ordinance.

7 **Section 5. Effective Date.** (a) The Charter amendment proposed in Section 2 of this  
8 ordinance shall become effective on the day following the date the election results are  
9 certified for the regular municipal election held on October 7, 2014, if approved by a  
10 majority of the qualified voters of the City and Borough voting on the question set forth in  
11 Section 4.  
12

13 (b) Sections 3 and 4 of this ordinance authorizing the submission of the ballot  
14 proposition to the qualified voters of the City and Borough shall become effective 30 days  
15 after adoption of this ordinance.
