I. ROLL CALL

Chair Loren Jones called the meeting to order at 6:00 p.m.

HRC members present: Loren Jones, Maria Gladziszewski, Karen Crane and Debbie White (telephonically).

Other Assemblymembers present: Mayor Mary Becker and Assemblymember Jerry Nankervis.

Staff present: Deputy Clerk Beth McEwen, CDD Senior Planner Teri Camery

II. APPROVAL OF AGENDA

There being no changes, the agenda was approved as presented.

III. APPROVAL OF MINUTES

A. December 21, 2015 - Regular Assembly Human Resources Committee Meeting Minutes

Hearing no objection, the minutes of the December 21, 2015 Regular Assembly Human Resources Committee meeting were approved.

B. December 22, 2015 - Special Assembly Human Resources Committee Meeting Minutes

Hearing no objection, the minutes of the December 22, 2015 Special Assembly Human Resources Committee meeting were approved.

V. AGENDA TOPICS

- A. Board Matters
 - 1. Wetlands Review Board Annual Report and Appointments

The meeting packet contained the annual report of the Wetlands Review Board. Community Development Department Senior Planner Teri Camery was present to answer any questions the HRC members had regarding the work of the board.

Ms. Camery gave a brief overview of the annual report in the packet. She noted one correction needed to the report and that was the addition of special meetings on October 8 and October 29, 2015. A majority of the work of the board over the past year has been on the draft Wetlands Management Plan which was released in September 2015 and following a list of extension revisions, they anticipate the consultant will have the next draft of the plan to be released in February 2016.

Ms. Crane asked if the LiDAR mapping that was completed in 2013 included the areas of concern relating to the flood plane management.

Ms. Camery stated that the imagery from the LiDAR mapping project had to conform with the requirements of the federal grant, which is not addressing flood issues. She stated that CDD Planner Eric Feldt could answer those questions better than she could. Her recollection was that Mr. Feldt followed up with the same consultant who did the LiDAR imagery and then there was an additional contract that refined this work for flood mapping purposes.

Ms. Crane also asked if there was a replacement yet from the Planning Commission for Mr. Miller's WRB seat. Ms. Camery said they do not anticipate that happening until at least the second Planning Commission meeting to be held in January.

Ms. White asked if the LiDAR imaging would ever been available outside of the CBJ system. Ms. Camery stated that the grant requires that the LiDAR and the imagery be open to the public. She said that the way it is set up right now, if someone comes to CBJ with a hard drive of sufficient size, that data could be provided. She said they are working on coming up with another system to provide access. She said some of the data is currently available on the University of Alaska GIS website. She said she would send follow-up information to Ms. White on how to access that information.

MOTION by Ms. Gladziszewski to recommend the appointment of Hal Geiger, Amy Sumner, and Irene Gallion to the Wetlands Review Board to terms expiring December 31, 2018. *Hearing no objections, the motion carried.*

Possible Evaluation of CBJ Boards/Commissions

Chairman Jones noted that at the last HRC meeting, a list of all CBJ Boards and Commissions was distributed to the members and the members were asked to consider any they felt were in need of review/evaluation similar to the recent review/evaluation of the Social Services Advisory Board.

Ms. White said she did not have any particular board to be reviewed but was very surprised by the shear number of CBJ boards that do exist.

Mr. Jones noted that he did attend the Juneau Commission on Aging (JCOA) retreat which was held earlier in the day, from 10am-2:30pm. He stated that the JCOA is dealing with a lot of issues and he believes they will most likely be coming to the Assembly with changes that they would like to see in their current resolution which may deal with membership and their duties as described in their governing resolution. He said the HRC will most likely be seeing something on their agendas about this sometime in June or July.

He asked staff about the status of the resolution reducing the number of members on the Juneau Human Rights Commission. Ms. McEwen noted that is on the Assembly's consent agenda for the January 11, 2016 meeting.

Ms. Crane noted that the Hospital Board has been discussing potential changes. She said they are not yet ready to come forward with those but that they will most likely be appearing on the agenda sometime later in the year.

Mr. Jones said that those two boards, plus the Social Services Advisory Board grant change over process will most likely keep the HRC agendas full enough for the year's review of boards.

Ms. Gladziszewski mentioned that it may also be time during the course of this next year to look at the Parks and Recreation Advisory Committee and have a dialogue with them since they do have new membership and leadership on the committee as well as the new leadership in the department.

Mr. Jones mentioned that near the end of the year and the beginning of 2017, the Treadwell Arena Advisory Board's scheduled review will be taking place.

B. Liquor Licenses

1. Liquor License #586 Coho's Bar and Grill, LLC Mid-Cycle Protest

Ms. McEwen reported that this is a mid-cycle protest. Each liquor license renewal is issued every two years but that Alaska Statutes allow an opportunity for local governing bodies to protest the continued operation of a license provided it is filed by January 31 of the second year of the license period.

She noted that this license in particular is no longer operating in that location and they are delinquent in their sales tax filings as well as payment of the sales tax and the associated penalties and interest payments. She mentioned that earlier in the day, Mr. Jones had inquired as to whether this protest recommendation would have any adverse affects on the liquor license application that was before the Assembly in December for Mac Ventures, LLC d/b/a McGivney's Sports Bar and Grill. Ms. McEwen said that the mid-cycle protest of the Coho's license does not have any affect on the Mac Ventures application since it is not a transfer but rather a brand new license for Mac Ventures.

Ms. McEwen provided clarification to the HRC members about the types of licenses and the transferability, or not, of any Beverage Dispensary - Tourism license.

MOTION by Ms. Gladziszewski to recommend the Assembly protest the continuation of the Coho's Bar and Grill Beverage Dispensary License #586 based on the unfiled and delinquent sales taxes, penalties, and interest. Hearing no objection, the motion carried.

Ms. McEwen noted that the certified letter was sent to the Coho's Bar and Grill both via certified mail and regular mail. The letter sent via certified mail was returned as "rejected" and the action on the license is on the Assembly agenda under New Business. The letter informs the licensee of their right to an informal hearing before the Assembly should they choose to exercise that right.

Description: On December 2, 2006, the Assembly held an Affordable Housing Summit in a joint meeting of the CBJ Assembly, Planning Commission, and the Affordable Housing Coalition. As an outcome of that Housing Summit, the Assembly adopted Resolution 2390 creating the Juneau Affordable Housing Commission. The Commission was established for a three-year period beginning January 2007 to make recommendations to the CBJ Assembly, through the Lands Committee, on all aspects of affordable housing. The Commission became a continuing CBJ Commission on November 23, 2009 with Resolution 2506 which repealed Resolution 2390.

Membership: Nine members - The commission membership shall be drawn from the public, with appropriate expertise including, but not limited to, homelessness issues, land management, real estate, construction, financial, taxation, permitting, and energy and environmental efficiency to be appointed by the Assembly based on the recommendation of the Human Resources Committee. The commission may also include non-voting liaison members from the Juneau Homeless Coalition and other agencies of similar expertise, as needed.

The Juneau Affordable Housing Commission has used the year 2015 to further projects that had been introduced in the previous year, as well as addressing many more issues in an attempt to alleviate the cost of housing. This topic has been identified as a crisis in our community, and this group of professional people has come together from all facets of Juneau to investigate and implement solutions to this problem. This letter will serve as a report of our activities during this last year, including actions taken by the Commission, participation in community events, and topics that were brought to our attention by other entities.

Affordable Housing Commission History and Mission

In December 2006 the CBJ Assembly held an Affordable Housing Summit including the CBJ Assembly, the Planning Commission and the Affordable Housing Coalition. In January 2007, the Assembly adopted Resolution 2390 establishing the Juneau Affordable Housing Commission to make recommendations to the CBJ Assembly, through the Lands Committee on matters affecting affordable housing in Juneau. With Resolution 2506, adopted in November 2009, the three-year sunset provision of the Affordable Housing Commission authorization was removed and it became a continuing commission of the CBJ with the added responsibility of making recommendations to the CBJ for solicitation, evaluation and recommendation of proposals for CBJ-funded affordable housing grants and loans.

The work completed by the Juneau Affordable Housing Commission (AHC) in 2015 included:

Accessory Apartment Grant Program

This program, initiated in 2014 is now complete and fully functional as of December 2015. The amount per Accessory Apartment was amended to \$6,000 per approved application. The AHC has worked diligently on this project, and anticipates it providing 12 new housing units in the community for the low cost of \$72,000.

Housing Action Plan

A consultant was hired to prepare a Housing Action Plan with the goal of getting Juneau's housing market "unstuck". This plan has been completed and presented to the Assembly, and has been refined to include a set of specific Action Items that will eventually return the community's housing market to a healthy state.

These action items are:

- •Create a new, housing-centric comprehensive plan
- •Prioritize assisted living for seniors
- •Prioritize workforce housing
- •Develop detailed neighborhood plans
- •Develop downtown strategy
- •Update zoning tools with a focus on housing
- •Clearly tie infrastructure to zoning
- •Develop new priorities for the use of Juneau lands
- •Coordinate business community efforts around housing
- •Hire or designate a full-time housing coordinator for the City
- •Increase the funding and purpose of the Housing Fund

The Action plan has been completed. A Chief Housing Officer is being recruited at this time to begin fulfilling these action items. It is planned that the community will see the plan in February/March of 2016, and the AHC will take their comments under consideration. After the public review and any necessary revisions, we hope that the Assembly will review and adopt the plan in its entirety.

6th Street Lots

The Affordable Housing Commission was involved in requesting a formal disposal plan for the existing lots on 6th Street on Douglas.

• Tax Abatement Law

AHC members Russ McDougal and Norton Gregory testified on the tax abatement law at the legislature and were received favorably. The CBJ is in favor of making tax abatement within 3 years instead of matching the State's 5 year policy, and Russ McDougal proposed that the AHC make a statement to the Assembly asking for tax abatement to match the State's policy. The group passed a unanimous motion to make a statement to the Assembly that the AHC supports a 5 year period for the tax abatement policy.

 Supported the Land Management Plan update, Pederson Hill Rezone, Renninger Subdivision, and CIP Priorities

The AHC voted unanimously to support the draft Land Management Plan update which included several policies for using CBJ property to support housing production and proposed several parcels to be disposed of for residential development. The Land Management Plan is scheduled to be heard by the Assembly Committee of the Whole on February 1st, 2016.

The AHC has been involved in planning and support of the Pederson Hill Rezoning project.

The City has completed a minor subdivision in order to finalize a land trade with the Christ Evangelical Lutheran Church of Juneau. The land trade provides an access route to the much larger parcel which would be subdivided into single family and multifamily lots for new housing. Lands and Resources has recorded the land trade for the Christ Lutheran Church, firming up plans for Pederson Hill. Lands is currently preparing the preliminary plot for this development.

The Renninger subdivision has been recorded and the access road, "Jackie Street" is officially slated to be completed next summer.

Pederson Hill is CIP priority number one, and has expanded from the original plan, having gone from 60 units to 300 units with smaller lots.

The AHC passed a unanimous motion of support for the CIP priorities as proposed by the Lands and Resources Division.

- The Affordable Housing Commission heard presentations throughout the year on a variety of topics including:
 - Colleen Bickford, Carma Reed HUD
 Colleen Bickford and Carma Reed presented on the role of HUD in the Juneau housing market, and offered any help they can give to work with the AHC. HUD contributes money annually to Alaska, with most HUD funds going through State and Tribal entities. They contribute funding for Section 8, public housing, and 10 VA HUD housing vouchers in Juneau. Also, the 811 housing grant has awarded \$7 million to help deinstitutionalize people that do not need that level of care. Carma Reed said that the funds are entitlement funds, HOME funds and CDBG funding. CDBG is intended to go to local governments to help meet their needs. She noted that the Commission should consider how the CDBG can proactively help them achieve their goals.
 - O Assisted Living Project Sioux Douglas presented on the Senior Assisted Living Project. She discussed history, features, and the status of the project. The Senior Citizen Support Board voted to pursue a purchase option at Vintage Park, as opposed to supporting an MHT property. The developer is Ted Johnson of Marathon Development. The Project is 100 units, and they hope to have it complete by mid-year, 2017.
 - Interest in the Gastineau Apartments
 Wayne Coogan presented updates to the group on the Gastineau Apartments. The AHC retains an interest in the outcome of this property and its impact on housing in Juneau.

- O Mobile Home Down Payment Assistance Loan Pilot Program
 The AHC commissioners have been working diligently with bankers regarding the
 mobile home loan program, and have opened up participation to include other banks and
 entities. True North remains the most solid participant and the AHC plans to continue
 developing this program in the coming year. This program is currently being reviewed by
 the CBJ Law Department.
- O Alaska Coalition on Housing and Homelessness Conference Lloyd Pendleton, director of Utah's Homeless Task Force, was a guest at the meeting of Alaska Coalition on Housing and Homelessness 2015 Annual Conference, and presented on how he used the Housing First model in Utah to almost eliminate homelessness.
- o VOA application for Housing Funds

The group has discussed the loan application of the Volunteers of America. The applicant is currently seeking conceptual support and will pursue the loan at a later date. The Commission drafted a letter urging the Assembly to support this project.

Subject: Parks & Recreation Advisory Committee 2015 Annual Report

The City & Borough of Juneau Parks & Recreation Advisory Committee (PRAC) meets the first Tuesday of each month at 6:00 P.M. in the Assembly Chambers. The PRAC is comprised of nine members appointed by the Assembly for three-year terms.

In 2015, PRAC included members from a broad-spectrum of the community including professionals, construction trades, state and federal employees, local non-profits, and sports clubs who brought their understanding and leadership in developing and maintaining CBJ Parks and Recreation (P&R) programs. The PRAC terms are staggered so there is continuity by overlapping appointments. In 2015 we welcomed three new members to the PRAC and had an entire year working with Kirk Duncan as the Director of the Department. PRAC's working relationship with the Department has increased as a result of the active and insightful engagement by Mr. Duncan. The PRAC, along with the Staff of Juneau Parks and Recreation Department have made lasting impacts on Juneau's recreation opportunities.

In 2015 PRAC held eleven public meetings and one retreat. The retreat focused on working with P&R in redefining the mission statement of the department, completing a SWOT (strengths, weaknesses, opportunities and threats) analysis, and developing priorities for PRAC and the department. Cost recovery of facilities, updating the out-of-date P&R Comprehensive Plan, and empowered boards for the pools and arena were discussed.

Over the last year during its eleven meetings, the PRAC took public comment on a wide range of issues, providing support for several Parks & Recreation initiatives, and making recommendations to the Assembly. Planning and management highlights of 2015 include:

2015 was a big year for Zach Gordon Youth Center. The year brought the completion of a new kitchen, the retirement of long time-manager Kristi West, and the start of incoming manager Jorden Nigro's time with the Parks and Recreation Department. The City was asked to take on the Body and Mind (BAM) after school program and the Young Parent Healthy Teen Center, both of which are now under the Zach Gordon umbrella of programs. The opportunity to be more involved in the community and offer more healthy activities to youth is a great fit for P&R and we are excited to grow our programming and serve more kids in Juneau.

In 2015 there was significant effort in unifying the various P&R facilities and divisions to work towards common goals. Focus included customer service, operations, efficiencies, revenue generation, and marketing and has strengthened the facilities and departments as a whole.

Preliminary numbers indicate that use at the Treadwell Arena was up nearly 20% with revenue increasing and expenditures declining. This resulted in the arena's highest cost recovery to date at just over 60%. Commercial use was also up over the previous year

and had a significant increase of 30% in revenue generated over revenue generated in 2014. Areawide Recreation programs indicate that volleyball participation is consistent with previous years. P&R awarded the soccer camp to the Juneau Soccer Club for its management and the first year was successful.

On behalf of the PRAC, we would like to thank Parks & Recreation staff for their hard work in providing the facilities and services that contribute to the quality of life for us all in Juneau. They have made significant efforts to become more efficient and do more with less. The Department's facilities, staffing and programs add significantly to the quality of life of our residents and visitors to the Capital City. We would also like to thank the Assembly for their support and, in particular, our current Assembly Liaison Maria Gladziszewski for her guidance.

Description: 69.05.180 Appeals. b) Board of appeals. (1) In order to provide an appeal mechanism for controversies involving taxable sales, sales taxes, penalties and interest, and exceeding \$500.00, and in order to hear appeals from decisions of the manager as provided under subsection (a) of this section, there is established a board of appeals which shall consist of five members appointed by the assembly for staggered three-year terms.

Membership: ... There is established a board of appeals which shall consist of five members appointed by the assembly for staggered three-year terms. To the extent possible, one member of the board of appeals shall be a certified public accountant, one member shall be licensed to practice law in the state, and the remainder shall be members of the general public. The board of appeals shall elect from its membership a chair, a vice-chair and a secretary. Three members of the board of appeals shall constitute a quorum for the transaction of business. The City and Borough shall provide secretarial and other staff support required by the board of appeals. No member of the sales tax board who has served for three consecutive terms or nine years shall again be eligible for appointment until one full year has intervened, provided, however, that this restriction shall not apply: (A) If there are no other qualified applicants at the time reappointment is considered by the assembly human resources committee, or (B) To qualified board members serving in board seats for which a specific occupation or expertise is set forth by ordinance.

Term Limits: No member of the sales tax board who has served for three consecutive terms or nine years shall again be eligible for appointment until one full year has intervened, provided, however, that this restriction shall not apply: (A) If there are no other qualified applicants at the time reappointment is considered by the assembly human resources committee, or (B) To qualified board members serving in board seats for which a specific occupation or expertise is set forth by ordinance.

Meetings: At the call of the chair upon receipt of an appeal by the Clerks Office.

Special Facts: 69.05.180 Appeals.... 2) The board of appeals shall conduct a hearing on a protest no more than 60 days after the protest is filed. Decisions of the board of appeals shall be in writing and shall be maintained and indexed by the manager for review by the public. Records and proceedings before the board of appeals are public, except that the board may deliberate in closed session. The board's authority in its review of sales tax appeals includes the authority to recommend, in writing, that the manager compromise and abate penalties and interest, and to recommend, in writing, that the manager negotiate and enter into payment plans for delinquent sales taxes, penalties and interest.

RE: Liquor Licenses

In an effort to save paper and reduce duplication, the materials pertaining to tonight's liquor licenses can be found in your Assembly meeting packet in two sections. Those licenses being recommended for no protest by staff can be found in the Consent Agenda section of the packet. Those licenses being recommended for protest by staff can be found in the New Business section of the packet.

The deadline for staff to be able to recommend protest of a license prior to Assembly action is 10-days, which in the case of all those on this date's agendas, was Friday, January 29. This gives Clerk's staff time to send a certified letter to the licensee notifying them of the basis for protest recommendation and notifies them of their right to an informal hearing before the Assembly as provided for in CBJ Code 20.25.

In the batch of licenses that are on the Feb. 8 Assembly Consent Agenda, the **Fishbone, LLC d/b/a Rockwell Beverage Dispensary License #4349** needs some additional explanation. The initial recommendation from the Police Department was for the Assembly to waive its right to protest. On Monday, February 1, staff was made aware that the licensee had held an underage "Rave" fundraiser (see Facebook advertising on pages 2 & 3) over the weekend but had not obtained the necessary de-designation permit. CBJ staff discussed this with Alcohol Beverage Control Investigative Officer III Steve Johnson and Officer Johnson investigated and issued the attached Notice of Violation (N.O.V). Officer Johnson told me that he discussed the permit process with one of the co-owners of the establishment and that they indicated they would be following the necessary permit process for any future events.

Deputy Chief Mercer was made aware of this incident and is still recommending the Assembly waive its right to protest the renewal but asked that the Assembly be briefed to the fact that "after JPD gave its approval for the renewal, the establishment had this incident and was subsequently issued a N.O.V. from the State."

- (1) the premises are a bona fide restaurant;
- (2) there is supervision on the premises adequate to reasonably ensure that a person under the age of 21 will not obtain alcoholic beverages; and
- (3) it is unlikely persons under the age of 21 will enter and remain on the premises for purposes other than dining.
- (b) The board will generally presume that the premises are a bona fide restaurant for purposes of (a)(1) of this section if

- (1) the premises are licensed as a restaurant or eating place;
- (2) at least 50 percent of the gross revenue of the licensed business is from the sale of food and non-alcoholic beverages; or
- (3) the premises are a facility at which the patron's primary activity is dining.
- (c) For purposes of (a)(3) of this section, the board generally will presume that premises are unlikely to be entered by persons under the age of 21 other than for purposes of dining if no entertainment other than dining is provided or available. "Entertainment" includes live music, dancing, pool and other table games, sports, pinball, and video games.
