# **Board Appointments - Eaglecrest Board & Airport Board**

The Full Assembly sitting as the Human Resources Committee (HRC) will be meeting immediately preceding this Special Assembly meeting to consider applications for the vacant seats on the Eaglecrest Board and Airport Board. The HRC will forward its recommendations to the Assembly for appointments to the following seats:

Eaglecrest Board - three (3) seats for full terms beginning July 1, 2016 and expiring June 30, 2019 and one (1) seat for an unexpired term beginning July 1, 2016 and expiring June 30, 2018.

Airport Board - three (3) seats for full terms beginning July 1, 2016 and expiring June 30, 2019

Hearing no objection, the above appointments were made as recommended.

Mr. Jones reported that there is one Airport Board seat remaining open and applications for that seat will be accepted until July 15 with consideration of any of the applications through the regular (non-empowered board) application review process at the regular HRC meeting on August 1. Mr. Nankervis asked if the Assembly needed to affirm that incumbent Ron Swanson will continue to serve past his term expiration until that seat is filled. Mr. Jones said there is a provision in the board rules of procedure that already provide for that and Mr. Swanson said he would be willing to continue to serve until his seat is filled.
