I enjoy and care about our community in Juneau, I love spending time at Eaglecrest, and it would be an honor and pleasure to help ensure that Eaglecrest is a vibrant part of our community. I enjoy both downhill and cross country skiing, and have skied over 120 days this "winter" (and counting!). Through this, I see a lot of what Eaglecrest is doing, and how users are experiencing it, and I will have an informed and impassioned perspective with which I hope to support operations. Although I'm applying in my personal capacity, in my professional capacity I run a non-profit (Discovery Southeast), and my experience there has some relevance. Both organizations are community assets dedicated to giving our community positive outdoor recreation and formative experiences. In general, I think my experience managing finances, handling personnel, and overseeing community programs at Discovery Southeast would be helpful on the Eaglecrest board since the board provides guidance on many of those same issues. My fiduciary record is strong, having overseen my organization's finances grow by an order of magnitude in some areas in the 5 years I've been there. I spend a lot of time reviewing balance sheets and profit and loss statements with an eye towards financial health and sustainability. It's also important to have experience with a "double bottom line," since Eaglecrest needs to provide experiences as well as manage finances. I also have experience in tourism, specifically on public lands, which is relevant since Eaglecrest is increasingly looking to summer tourism as a revenue source. To provide sustainable funding, my non-profit operates a bookstore and gift shop at the Mendenhall. We promote our outdoor education mission and several community artists and groups, while running a viable visitor-oriented operation. Besides tourism experience, this also brings experience in public private partnerships, which should be positive for Eaglecrest as it has opportunities to work more closely with the Eaglecrest Foundation, Juneau Parks Foundation, and private vendors to boost its financial viability. Finally, although I'm not currently practicing law, I have a law degree, have litigated administrative issues, have clerked for the Alaska Supreme Court, and have experience in liability and risk management issues for outdoor recreation. I think that background is valuable on this board because Eaglecrest is navigating administrative issues such as a liquor license, and presumably has liability related issues regularly, and I'd hope to add my voice to those conversations.
